

1. Thanks to the institutional framework, the Convention supports implementation and application on the ground

The 1992 Water Convention

- Negotiated by ECE countries
- Negocié par les pays CEE
- “Living document”
- “Document évolutif”
 - UNECE Secretariat
 - Secrétariat CEE-ONU
 - Adaptable institutional framework
 - cadre institutionnel flexible


The 1997 Watercourses Convention

- Negotiated by international law Commission, GA
- Negocié par la commission du droit internationale, AG
- No secretariat
- Pas de sécretariat
- No institutional framework
- Pas de cadre institutionnel



The 1997 Watercourses Convention


- Same object: Cooperative use, management and protection of international watercourses
- Même objet: usage cooperative, gestion et protection des cours d'eau internationales
- Principles of equitable and reasonable use, prevention of significant harm
- Principes d'utilisations équitable et raisonnable, prévention du dommage significative

- Forming joint institutions is an obligation under the 1992 Convention
- Ressources:

 - Regular workshops on transboundary joint bodies by UNECE and partners






- More benefits than usually perceived

- Application of guidance
 - Drina
 - Okavango Basin
 - Sio-Malaba-Malakisi

Climate Change Adaptation in transboundary basins

Adaptation aux changements climatiques dans les bassins transfrontières


- Transboundary cooperation in adaptation is more effective, efficient and avoids negative unilateral measures
- Complemented by soft law tools: model provisions on tb flood management, etc.
- Task Force on water and climate created in 2006: elaborated Guidance on Water and Climate
- Programme of pilot projects
 - Sava
 - Dniester
 - Neman




Climate Change Adaptation in transboundary basins

Adaptation aux changements climatiques dans les bassins transfrontières

- Partnership with INBO
- Global platform to exchange experience: regular workshops, global network, web platform
- Analysis of results: collection of good practices and lessons learned
- Input into global processes (e.g. UNFCCC)
- New work on financing CC adaptation
- Global workshop on water scarcity 11-12 December 2017




Global network of basins working on climate change





- Objective: Foster transboundary cooperation by
 - Identifying intersectoral synergies
 - Determining policy measures and actions that could alleviate tensions
 - Assisting countries to optimize their use of resources
- A series of assessments of basins for intersectoral links, trade-offs and benefits.



Water-food-energy-ecosystems nexus

Interactions entre l'eau, l'alimentation, l'énergie et les écosystèmes

- Synthesis report launched in 2015
- Highlights
 - Challenges:
 - Different planning cycles of sectors
 - Lack of horizontal coordination mechanism
 - Opportunities:
 - Common interests e.g. tourism
 - Better coordination of dam operations brings benefits for hydropower and flood protection


