

The IAS are **the second cause of biodiversity loss in the world**, behind the destruction of habitats.

Causes that aggravate the problem of bioinvasions in the last years:

- Increasing trades, travels and transport of goods (GLOBALIZATION).
- Alteration suffered by ecosystem along these years.
- Climate Change.
- Ignorance about the effects of these introductions.
- The lack of effective legislation on IAS (2014).
- **REACTION TIME OF ADMINSTRATIONS. LACK OF PLANNING.**






LEGAL COMPETENCES

Actually, the efforts of the Administration has the focus in to increase extraction, control erradication or prevention work.


However the erradication of the IAS present in the Guadianas river needs to develop of actions pograms in the médium and long term, in order to recover the good health of the fluvial ecosystem.







NOTICE OF PRESENCE




REAL PRESENCE

FINANCING MEASURES


- Direct budgets of the competent agencies.
